6. **Transfer/Euthanasia.** In the event that you are unable to keep this animal, you agree to notify MAC immediately by either mail or phone so that we may retrieve the animal from you. If MAC will be retrieving the animal you must understand that retrieval is based upon MAC's foster openings to place the dog and the availability therein and our ability to reintegrate the animal back into our rescue after a full assessment of the animal and any issues therein with the animal. A reasonable period of time shall be defined by case law and the court system. Calling, acting upon or threatening to take the dog to animal control, a shelter, humane society or any place other than MAC allows MAC to proceed with all allowable legal proceedings against the adopter or affiliated parties for all damages incurred.
- You agree not to abandon, give away, sell, place in another home or dispose of the animal in any way without providing MAC the opportunity to re-home the animal. See above paragraph for reasonable time to obtain the animal and re-home the animal.
 - You agree that you may NOT euthanize the animal except in the case of the animal's terminal illness or injury, or old age accompanied by pain and suffering. A licensed veterinarian must perform euthanasia and you will notify MAC of the euthanasia.
7. **Lost Animal.** You agree to make a serious effort to find the animal if it becomes lost, and agree to:
- (a) filing lost reports with the local police, animal control authorities, animal shelters, local veterinarians, and MAC
 - (b) posting lost animal signs, and
 - (c) putting an ad in the paper and/or networking the animal on social network sights, specifically, but not limited to For the Love of Louie on Facebook.
 - (d) notify us that the dog is lost.
8. **Breach of Agreement/Liquidated Damages.** MAC reserves the right to follow through on this adoption agreement in order to protect the welfare of the animal. In the event that you do not comply with the terms of this adoption agreement, or the animal is abused or neglected while in your care, one of our remedies will be to immediately recover the animal from you upon verbal or written demand. To this end, you agree to allow MAC immediate visits to your home to assess the status of the animal, if needed, and the conditions under which the animal is kept. After the demand and home review, if needed, the animal will be immediately surrendered to us. In addition, without waiving any of our rights under this agreement or the law, you will owe MAC a payment of \$250.00 as liquidated damages for the costs and expenses in connection with your breach of this agreement.
9. **No Liability.** MAC is not liable for any claims, legal action, losses, injuries, damages, costs, expenses or liabilities whatsoever in connection with your adoption or ownership of the animal. Once the animal is placed with you and this Adoption Agreement is signed you assume all responsibility for the animal.

Szymanski still fired, panel rules

A panel of Macomb County assistant prosecutors has upheld the firing of Jayne Labuda Szymanski, who was dismissed by Macomb County Prosecutor Carl Marlinga late last month for distributing what he considered racist campaign literature.

The panel, which heard testimony from Marlinga and at least one of his assistants last week, issued the opinion Tuesday.

Though panel members sided with Marlinga on the campaign literature, they disagreed with his other reasons for the firing: an alleged assault of a campaign worker, alleged theft of campaign signs and the alleged theft of food at the county courthouse.

Szymanski made a failed run for Sterling Heights District judge. Assistant Prosecutor Steve Sierawski won. Less than a week before the Nov. 3 election, Marlinga fired Szymanski and called the literature, which showed a handcuffed black man in jail, racist and an embarrassment to his office.

Szymanski's attorney, Albert Addis, said Tuesday's outcome was expected.

"How could they stand up and say they disagree with what Carl Marlinga thinks is racist?" Addis asked, referring to the panel of assistant prosecutors from Marlinga's office.

Szymanski has at least two other options: a hearing before an arbitrator and a \$2-million wrongful-dismissal suit against Marlinga and the county. No dates have been set for either

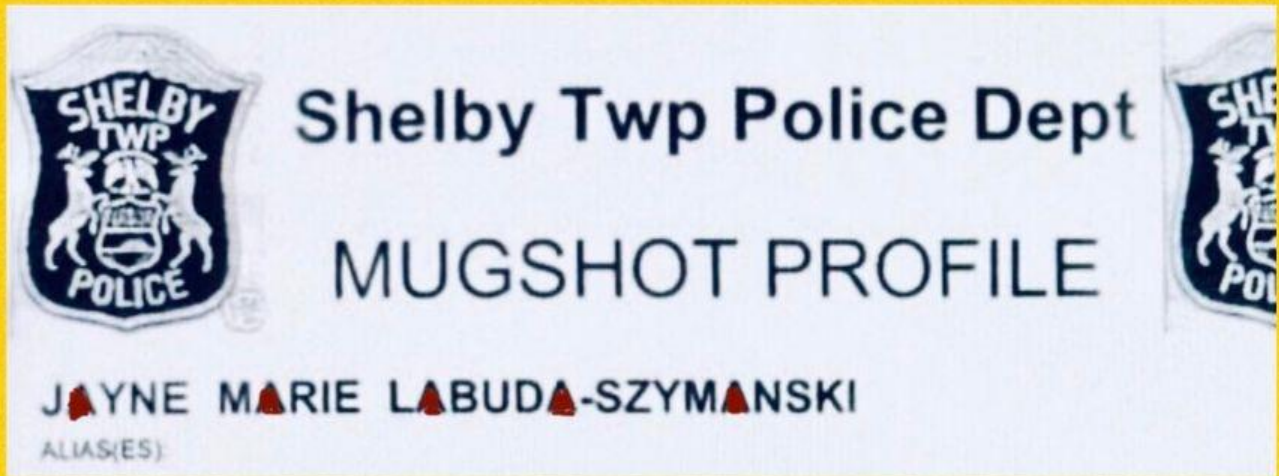

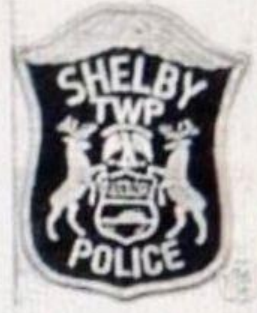

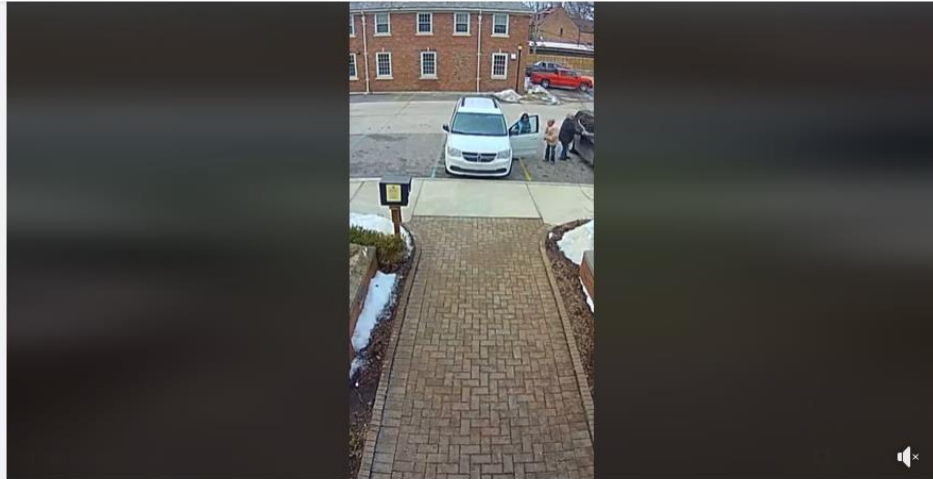
